1. Cayuse Human Ethics-to replace IRBIS in early April

The current online system for the internal review of human ethics research, IRBIS, will be replaced by Cayuse Human Ethics in April. I saw an overview of the new platform last week and it seemed user friendly. Some positive changes include that several redundant questions have been removed or streamlined which should enhance the efficiency of submitting protocols. Please note one important difference is that in Cayuse, anyone listed as an investigator is required to certify the application prior to moving to the review stage in contrast to IRBIS in which only the Principal Investigator had to certify the application to launch the review stage. If you have multiple investigator teams but wish for the Principal Investigator to be the only certifier, you may list additional investigators as Personnel. They will still receive communications and have access to materials when they login to Cayuse, but they will not need to certify the application prior to review. Several live trainings via zoom are planned, and recordings will be made available.

Complete details are available in the attachments titled: Cayuse HSR Go Live Announcement.pdf and Revised Cayuse HSR Go Live FAQs. A few key facts are summarized below:

- Beginning April 5, all new studies must be submitted in Cayuse Human Ethics
- IRBIS will be unavailable from 4/1 through 4/4 in order to prepare for the migration from IRBIS to Cayuse.
- Beginning April 12, modifications and renewals can be submitted in Cayuse
- **No modifications or renewals can be submitted from March 30 to April 11, so any urgent modifications or renewals must be submitted in IRBIS by March 30 at the very latest.**
- Active protocols will be migrated automatically.
- Expired/closed protocols will not be migrated.

If the timeline/implementation changes, I will alert you.

2. Cayuse to replace RAMSeS

RAMSeS (Research Administration Management System and electronic Submission), the portal we have been using for the internal routing of external grants and contracts will be replaced by a new system called Cayuse. Yes, the same Cayuse noted above. One of the beauties of Cayuse is it is a single platform in which multiple research-related processes will be integrated--including routing of grants/contracts, IRB, and conflict of interest processes. Another benefit

of Cayuse is it will communicate/work with ASSIST and Grants.gov. In other words, these application packages can be built in Cayuse and then directly submitted to some sponsors. So, although no platform is perfect, Cayuse has several clear advantages over RAMSeS. That said, I know change can be hard.

A few important facts to highlight:

- The current timeline indicates any applications that are started on or after July will need to be in Cayuse. If this shifts, we will alert you.
- Verna Leslie, our Pre-Award Administrator, has been an integral member of the campus wide working group testing Cayuse and planning for implementation--so we are in VERY good hands, as always, during this transition.
- Cayuse was created by the same group who created RAMSeS, so the platform is similar in many ways. Those involved in the working group suggest it will look very familiar to us.
- Verna will continue to enter most application information into Cayuse, as she has done for RAMSeS, so the felt impact of this on HHS PIs will likely be minimal.
- The Office of Sponsored Programs will prepare/disseminate training materials.
- I will create an abbreviated instruction document for Department Chairs who are tasked with reviewing and approving grants/contracts before they are submitted.

4. HHS OOR Equity Audit Updates

We have received many questions about the HHS OOR Equity Audit. To clarify, this is an audit of the HHS Office of Research, not the OOR conducting a broader audit of HHS. We have made tremendous progress on the audit this year. Please look for an email devoted solely to this topic later today. I welcome input as we are making key decisions about how to best disseminate our results and invite feedback in the fall. I will provide a mean for providing feedback in the other email.
